The tenderer shall be pre-qualified on the basis of the following criteria:

- Tenderer should have minimum turnover of Rs. **02.20** Lac in any one of the last three preceding financial years i.e. 2022-23, 2023-24 & 2024-25 in the tenderer name.
- The bidder is required to produce minimum three (03) copies of work order of the same nature of work of repairing/servicing of Electronic Weighbridge not less than 100MT (pit type or pitless) in any of the Govt. /PSU or in any other reputed firms in last three years. (Self attested Copy for the work order has to be enclosed with the offer and original copy has to be, produced to the EIC as & when asked for the same).

The tender shall be pre-qualified on the basis of documents furnished along with Techno-commercial bid, duly attested copy of audited balance sheet for the last three preceding financial year's 2022-23, 2023-24 & 2024-25 in support of turnover. The decision of the company will be final and binding in this regard.

It is to be noted that, in case of Company registered under Companies Act, turnover of the Company shall only be considered. The Company reserves its right to call for any additional information so as to check the eligibility of the tenderer.

Joint ventures/consortium/partnership are allowed to participate in this tender subject to the joint/several responsibility, in such cases the cumulative turnover of partners/members will be considered.

The price bid of only those bidders shall be opened who qualify in technical bid as per criteria laid in tender & only qualified bidders will be informed about price bid opening.

The tenderer who has been suspended/ banned by the company shall not be eligible to participate in this tender during the currency of suspension/banned period.

Offers furnished through any other mode shall not be considered. RSMML will not entertain any claim on account of postal delay/non-receipt. It also reserves the right to reject/cancel any or all tenders without assigning any reason whatsoever.

SECTION – I

DEFINITIONS, INTERPRETATIONS

DEFINITIONS: In the contract (as hereinafter defined) the following words and expression shall have the meaning hereby assigned to them, except where the context otherwise requires:

1. "**Agent**" shall mean the Agent for Giral Lignite Mines so notified by the company in this behalf.
2. "**Alteration/Variation order**" means, any order given in writing by the Engineer-In-Charge to the Contractor from time to time to affect Alteration/Variation from given Scope of Work. Such an order will be without any financial implication to the Company.
3. "**Approved**" shall mean approved in writing by the Company/Engineer-In-Charge.
4. "**Appointing Authority,**" wherever the expression is used shall mean the Managing Director of the Company.
5. "**RSMML**" or "**COMPANY**" shall mean "Rajasthan State Mines & Minerals Limited," having its registered office at C-89/90, Janpath, Lal Kothi Scheme Jaipur (Rajasthan) and Corporate Office at 4, Meera Marg, Udaipur (Rajasthan) including its successors and assignees or its representatives authorized to act on its behalf for the purpose of contract.
6. "**Contract Document**" shall mean collectively drawings, plans, specifications, agreed variations, if any and other documents constituting the tender and acceptance thereof.
7. "**Contractor**" shall mean the person or persons, firm or company, who's tender, has been accepted by the Company and shall include his/its/their legal representatives, administrators, successors and executors.
8. "**Contract**" shall mean the agreement between the Company and the Contractor for execution of the work/s including therein all documents such as invitation to tender, instructions to Contractor, general conditions of contract, special conditions of contract, job specification, general requirements, time schedule for completion of work, drawings, letter of acceptance /telegram awarding the work, alteration/variation order, agreed variations, if any etc. Any subsequent changes made in any of these documents, would be deemed to be a part of the Contract.
9. "**Completion Certificate**" shall mean the certificate to be issued by the Engineer-in-Charge when the work/s has/have been completed to his satisfaction as per terms of the contract.
10. "**Contract Rate**" or "**Schedule Rate**" or "**Tendered Rates**" or "**Rate of remuneration**" means rate entered in figures and words in schedule/s by the Contractor and accepted by the Company as payable to the Contractor for execution /performance of all contractual obligations.
11. "**Commencement of work**" shall be reckoned from the date of issue of letter of acceptance including the stipulated mobilization period.

12. **“Engineer-in-Charge”** shall mean the Officer so designated for the overall supervision, coordination, direction and administration of the contract work from time to time by the Company and shall also include the Head of SBU & PC – Lignite.
13. **“Managing Director/Management”** shall mean the Managing Director of Rajasthan State Mines and Minerals Limited.
14. **“GGM – Lignite”** shall mean Group General Manager for the SBU & PC – Lignite of RSMML or his successor in the office so designated by the Company.
15. **“Mines Manager”** shall mean the Mining Engineer so designated under Mines Act, 1952 for different Lignite Mines of the Lignite Division of Rajasthan State Mines and Minerals Limited.
16. **“Letter of Acceptance”** shall mean intimation by a letter/telegram to Contractor that his/its tender has been accepted, in accordance with the provision contained in the letter/telegram.
17. **“Mines”** shall mean Sonari Lignite Mines of the Company under SBU & PC Lignite situated in the district of Barmer.
18. **“Notice in writing or written notice”** shall mean a notice written, typed or printed sent (unless delivered personally or otherwise proved to have been received) by registered post to the last known business address or registered/Head/local office of the addressee and shall be deemed to have been received in the ordinary course of post.
19. **“Site”** shall mean the land or other place on, under, in or through which the work/s are to be carried out and other land or place or area/s provided by the Company for the execution of the contract.
20. **“Specifications”** shall mean directions, various technical specifications, provisions and requirements attached to and referred to in the contract, which pertain to the method and manner of performing the work/s and the materials to be furnished /used required to be used/consumed and/or provided for executing work/s as may be amplified or modified by the Company or the Engineer-in-Charge from time to time and notified/communicated to the Contractor during the course of performance of this contract and provide for the unforeseen conditions or in the best interest of the work/s. It shall also include the latest addition including all agenda or corrigenda or relevant rules, regulations, regulation codes.
21. **“Tender”** shall mean the offer submitted by the Contractor against this inquiry for acceptance by the Company.
22. **“Temporary Works”** shall mean and include all temporary work/s of every kind for the execution of the main work as incidental and ancillary thereto.

SECTION - II

Instructions to the Tenderer & General Conditions

1. Scope of Work

Details of the works are as tabulated below:-

1.1 The bidders will require submitting their sealed offers in the prescribed Performa enclosed herewith as annexure "II". The offer should be valid for a period of 90 days from the date of opening of the tender, during which party would not withdraw or modify their offer.

1.2 The party has to arrange for hydra crane/JCB, welding machines, Unskilled Labour, required rubber Paint, Fasteners and any other machinery/ equipment for carrying out the work.

1.3 The Load Cell, if found faulty; shall be replaced by the party and the cost of the same will be reimbursed by RSMML on actual basis.

- 1.4 Lowest bidder (L-1) would be decided on the basis of, overall lowest rates quoted by the bidder both in figures & in words, excluding GST (i.e. lowest in totality, without GST).
- 1.5 The period of completion of work will be for ninety (90) days from the date of issue of the work order.
- 1.6 The total quantum of work may vary as per the actual field conditions as well as our requirement of the job. Lodging/ boarding facility for the staff shall be provided by the party itself and RSMML would not bear any charges for the same.
- 1.7 The safety of manpower deployed by the party will be in the scope of party itself and RSMML will not be liable for any compensation against any kind of mishappening / accident occurred during the execution of the work.

2. **PRE-QUALIFICATION OF TENDERER:**

- (i) Tenderer should have minimum turnover of Rs.2,20,000/- in any one of the last three preceding financial years i.e. 2022-23, 2023-24 & 2024-25 in the tenderer name.
- (ii) The bidder is required to produce minimum three (03) copies of work order of the same nature of work of repairing/servicing of Electronic Weighbridge not less than 100MT (pit type or pitless) in any of the Govt. /PSU or in any other reputed firms in last three years. (Self attested Copy for the work order has to be enclosed with the offer and original copy has to be, produced to the EIC as & when asked for the same).

3. **EARNEST MONEY DEPOSIT (Bid Security)-**

Bid Security amount Rs.8800/- to be deposited in favour of RSMML. Offers not accompanied with the requisite Bid Security will not be considered. While opening of the tender, the envelope containing Bid security will be opened first and in case the same is found as per tender requirement, then only offer will be opened.

The earnest money of a tenderer shall be forfeited in the following cases: -

- (i) If the tenderer withdraws or modifies the offer after submission of the tender and within the initial/extended validity period.
- (ii) If the tenderer does not submit the security deposit within stipulated period given in the tender document elsewhere in favour of tenderer.
- (iii) If the tenderer does not execute the agreement, in the prescribed form within one month of the date of work order /LOI issued in favour of tenderer.
- (iv) If it is established that the tenderer has submitted any wrong information/forged documents alongwith the tender or thereafter.

No interest is payable on earnest money or security deposit to the tenderer by the Company.

4. TWO PART TENDER:

Tenderers are required to submit their tenders in three separate sealed envelopes: duly superscripted on each i.e. containing "Techno Commercial Bid" other containing "Price Bids" and these sealed envelopes i.e. the envelope containing "Techno Commercial Bid" and the envelopes containing "Price Bids" should be placed in an envelope which should also be sealed and superscripted with the Tender No., Name of the tenderer and the Due Date in bold letters.

5. Documents to be attached with the TECHNO-COMMERCIAL bid:

Following documents are to be enclosed alongwith the offer:

- a) Tenderer descriptive form (Annexure I).
- b) A bid security of Rs.8,800/-
- c) Duly Attested Photocopy of Partnership Deed & Registration Certificate of the firm & copy of Memorandum and article of Association in case of a Company.
- d) Power of Attorney in favour of constituted attorney authorizing him to sign tender documents.
- e) Duly attested copy of turnover of Rs.02,20,000/- in any one of the last three preceding financial years i.e. 2022-23, 2023-24 & 2024-25 in the tenderer name.
- g) Copy of tender document duly signed & stamped as token of acceptance.
- h) The bidder is required to produce minimum three (03) copies of work order of the same nature of work of repairing/servicing of Electronic Weighbridge not less than 100MT (pit type or pitless) in any of the Govt. /PSU or in any other reputed firms in last three years. (Self attested Copy for the work order has to be enclosed with the offer and original copy has to be, produced to the EIC as & when asked for the same).
- i) Copy of the PAN card & GST registration Certificate.
- j) Undertaking as per Annexure-III that no condition is mentioned in the Annexure -II (Price Bid).

- l) Amendments/Clarifications issued by GoR from time to time regarding RTPP Act, 2012 and RTPP Rules, 2013 may also be applicable.

6. PRICE BID (ANNEXURE-II):

Price Offer to be given as follows:

- i. The rates offered should be submitted in the proforma prescribed at Annexure III. The rate quoted by the tenderer should be written both in "figures" & "words". In case of variation i.e. figure and words, the lower of the two would be considered.
- ii. The price bid should be in the prescribed format only.
- iii. No additions/modifications/alterations in the terms & conditions of the tender document should be written on the Price Bid or enclosed with the Price Bid. In case any such addition/ modification/ alteration is written or enclosed with the "Price Bid" then the same shall not be considered & may also result into disqualification of the tender. No correspondence in this regard would be entertained.

7. DELIVERY OF THE TENDER DOCUMENT:

The tender shall be submitted in two sealed envelopes, on the outer envelope being superscribing "TENDER FOR "Servicing/ Overhauling of 2 Nos. pitless weigh bridges of 100 MT capacity installed at Sonari Lignite Mines, RSMML, Barmer as detailed scope of work mentioned in tender documents ". The out cover shall be addressed to Manager (Mech.-Contract), RSMML, Khanij Bhawan, Jaipur. Tenders which do not comply with these instructions may be summarily rejected.

- I The tenders should reach the office of Manager (Mech.-Contract), RSMML, Khanij Bhawan, Jaipur on or before 25.08.2025 upto 03:00 PM.
- II RSMML shall not be liable for any delay & misplacement of tender sent by post / courier.
- III Offer on fax/e-mail will not be accepted.

8. SUBMISSION & OPENING OF TENDER (Techno Commercial Bid):

The tenderer should submit their sealed offer in the Office of Manager (Mech.-Contract) on 25.08.2025 upto 03:00 P.M. The Techno Commercial Bid of the tender will be opened in the office of Manager (Mech.-Contract), RSMML, Khanij Bhawan, Jaipur on 25.08.2025 at 3:30 P.M. in presence of the tenderers, who wish, to be present either in person or through an authorized representative at the time of opening of the tender.

The opening date of the Annexure- II i.e. PRICE BID shall be informed separately to those successful bidders who have qualified in the Techno Commercial Bid.

9. Period Of Contract

The contract period shall be three (03) months from the date of issue of Work-Order.

10. Submission of offers

The sealed offers should be submitted in the office of Manager (Mech.-Contract), SBU & PC-Lignite, RSMML, Jaipur on or before the date and time mentioned in the tender. The offers shall be opened on the date and time mentioned in the tender in the presence of the tenderer or their representatives. Late received offers will not be accepted.

11. Validity of offers

The tender offers should remain valid and open for acceptance for a period of 120 days from the date of opening of the tender. No modification or revision or withdrawal of the offer shall be allowed during the validity period or the extended validity period, if any. In case any tenderer does so, the Earnest Money deposit of such tenderer shall be forfeited. In case refusal to accept the job offered or failure to commence the work within the stipulated time period, the Earnest Money Deposit shall be forfeited.

12. SECURITY DEPOSIT

- I. The rates of Work Performance Guarantee as per the prevailing terms and condition of the Company are @ 10% of total contract value. The successful tenderer shall furnish a Security Deposit through any of the option in favour of RSMML, Jaipur within 15 days of the issuance of Letter of Acceptance. The successful tenderer shall furnish a Security Deposit by following options:
- II. As security for the due, proper and faithful fulfillment of the obligations under the contract, the tenderer will furnish to RSMML Security Deposit cum Performance Guarantee equal to 10% of total value of contract in the form of Demand Draft/RTGS/NEFT or in the form of Bank Guarantee in RSMML Performa by public Sector Banks and Private Sector banks as per schedule II of the Reserve Bank of India Act, 1954 as per list enclosed at annexure-IV having its Branch at Jaipur, within 21 days from the date of PO on the stamp paper of appropriate value. An undertaking as per annexure-XIII will also be submitted along with the B.G.
- III. The contractor may also opt to furnish SD by Fixed Deposit Receipt (FDR) equivalent to 10% of Total contract value issued from any Public sector bank (except SBI) /ICICI/Axis/HDFC Bank having its Branch office at Jaipur. FDR shall be in the name of RSMML on account of Successful bidder and discharged by him in advance. The accepting authority shall ensure, before accepting the Fixed Deposit Receipt, that the successful bidder furnishes an undertaking from the bank to make payment/premature payment of the Fixed Deposit Receipt on demand to the Company without requirement of consent of the successful bidder. In the event of forfeiture of the security deposit, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit without protesting by the contractor/him.

- IV. The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company, should the Contractor either fail to fulfill the contractual obligations or fail to settle in full, his dues to the Company, In case of premature termination of the contract, the Security Deposit will be forfeited and the Company will be at liberty to recover the loss suffered by it from the Contractor.
- V. The Company may deduct from the Security Deposit any sum due and any other sum that may be fixed up by the Company as being the amount of loss or losses or damages suffered by it due to delay in performance and/or non-performance and/or partial performance of any of the terms of the contract.
- VI. All compensation or other sums of money payable by the Contractor to the Company or recoveries to be made under the terms of this contract may be deducted from any sums which may be due to the Contractor from the company on any account and in the event of the such amount being insufficient the Contractor shall within ten days of such shortfall make good in cash, failing which the balance amount shall be recovered by way of invoking the bank guarantee furnished as security.
- VII. In the event of Bank Guarantee amount being insufficient, then the balance recoverable amount shall be deducted from any sum, then due or which at any time thereafter may become due to the contractor. The Contractor shall pay to the company on demand any balance remaining due.
- VIII. In case the Bank Guarantee is invoked for any reason/s, the contractor is required to furnish a fresh Bank Guarantee in the same format for the same amount and for the same period as the original Bank Guarantee within a period of 10 (Ten) days from the date of invoking of original Bank Guarantee.
- IX. In case of enhancement of quantum of work, due to any reason, the contractor shall furnish additional security amount. This security will be progressively recovered from the payment due to the contractor.
- X. The entire Security Deposit shall be refunded after the expiry of contract & completion of defect liability period of six (06) months from completion of work, provided the Contractor has fulfilled all contractual obligations and he has rendered "No claim and No Dues Certificate" to the Company.
- XI. In the event of security amount at any time during the currency of the contract falling short of the specified amount, due to enhancement of quantum of work, or due to any reason, the Contractor shall furnish additional security amount, so that the total amounts of Security Deposit will not be at any time less than the amount so specified. The Company may recover the same by way of additional deductions from the payment due to the contractor.
- XII. No interest is payable on S.D. amount.

13. ADDITIONAL PERFORMANCE SECURITY.-

In addition to Performance Security as specified in rule 75A of RTPP Act & rules, an Additional Performance Security shall also be taken from the successful bidder in case of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through e-Grass, Demand Draft, Banker's Cheque, Government Securities or Bank Guarantee. Explanation : For the purpose of this rule,-

- I. Unbalanced Bid means any bid below more than fifteen percent of Estimated Bid Value.
- II. Estimated Bid Value means estimated value of the work as mentioned in bidding documents.
- III. Unbalanced Bid Amount means positive difference of eighty five percent of Estimated Bid Value minus Bid Amount Quoted by the bidder.
- IV. The Additional Performance Security shall be refunded to the contractor after satisfactory completion of the entire work. The Additional Performance Security shall be forfeited by the Procuring Entity when work is not completed within stipulated period by the contractor.

14. Award of Contract

The company shall communicate to successful tenderer (L-1 bidder) to accept their tender offer/work order.

15. SIGNING OF THE CONTRACT AGREEMENT

- i. The successful tenderer shall be required to execute an agreement on non-judicial stamp paper of appropriate value under Indian Stamp Act (latest circular) with the company within 30 days from the date of intimation regarding acceptance of tender, LOA etc. The cost of execution of agreement including non-judicial stamp paper shall be borne by the contractor.
- ii. The contract agreement shall consist of –
 - i) An agreement on non-judicial stamp paper of appropriate value,
 - ii) Tender document, along with the addenda/corrigendum, if any.
 - iii) Telex/Letter of Acceptance &/or Detailed Letter of Acceptance.
 - iv) Agreed Variation, if any,
 - v) Any other document as mutually agreed.

16. Rate and Tax deductions at source

The company shall be fully entitled to deduct income tax and/or any other taxes levied at source as per the rules and instructions as may be applicable for this purpose from time to time.

The rate quoted by contractor shall be inclusive of all applicable taxes, duties as on applicable on the date of submission of the tender except GST. If GST is applicable on the contractor, the same shall be reimbursed by the company.

17. Terms of Payment

- i. For payment purposes the contractor shall raise the bill after completion of work in triplicate along with the supporting documents to receive its remuneration from the RSMML and the bills shall be duly verified by the Engineer In-Charge. The rates as accepted by the Company shall only be considered for billing purpose. The contractor shall submit an undertaking with bills bearing GSTIN and HSN/SAC code that “total GST has been deposited and returns have been filed for relevant tax period”.
- ii. Payment will be made through RTGS/NEFT. All bank charges / commission , if any shall be borne by the supplier.

18. Right of Company

The Company reserves the right-

- i. To accept or reject any or all the tenders, in part or in full, without assigning any reason, there to,
- ii. Not to accept the lowest tender or assign reasons for not accepting the lowest tender.
- iii. To increase/decrease the quantity and period of contract, without any additional obligation on it.
- iv. Not to carry out any part of work.
- v. To reject the offer, if is established that the tenderer has submitted any wrong/ misleading information or forged documents along with offer or thereafter.

The company may exercise any of the above right at any time prior to the award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the RSMML's action.

20. Termination of the Contract

- i. In case of failure to perform the job as required under this tender or observe any of the terms and conditions by the contractor, the company shall give a notice to rectify the default or breach within 07 days. Failure to rectify such default, breach may result in termination of the contract and forfeited of security deposit without any prejudice to the company's rights to claim damages/costs/loss etc caused by such default/breach. Such termination shall not absolve the contractor of the liabilities accruing till the date of such termination.
- ii. The contract may also be terminated in the event the contractor is being adjudged insolvent or going into Liquidation or Winding up of their business, or making arrangement with their creditors.
- iii. Notwithstanding anything contained herein above, the company in its absolute discretion may at any time terminate the contract without assigning any reason thereof by giving Fifteen days Notice to the contractor at their last notified address. In such an event the contractor shall not be entitled to raise any claim or demand for compensation, loss of profit and/or damages and/or

losses or costs by reason of such earlier termination on any ground whatsoever.

21. Criteria For Deciding L-1 Bidder

Lowest bidder (L-1) would be decided on the basis of the lowest rate offered quoted by the bidder excluding GST, if applicable.

22. Compensation

For Delay in commencement:

In case the Contractor fails to commence the work within 15 days from the date of issuance of Work-Order, the company shall recover a pre determined and agreed compensation @ 1% (One percent) of the total contract value on weekly basis from the contractor if the delay is on account of contractor subject to maximum 10% as per RTPP rules.

For Delay completion:

In case Contractor fails to complete the job within stipulated period and is established that the delay is on account of contractors lapses, the company shall recover a pre determined and agreed compensation @ 1% (One percent) of contract value subject to maximum 10% as per RTPP rules.

23. Compensation and Liability:

- a. The Contractor at his cost shall affect insurance for all the employees and persons engaged in the performance of the contract.
- b. In case of an accident in respect of which Workman's Compensation Act or Motor Vehicles Act, Fatal Accident Act or Mines Act etc. applies the Company shall not be liable for or in respect of any damages or compensation payable as per law in respect of or in consequence of any accident or injury to any workman or other person in the employment of the contractor or any of his involved third party etc and the Contractor shall indemnify and keep indemnified the Company against all such injury, damages and compensation and against all claims, demands, proceedings, costs, charges and expenses, whatsoever in respect of or in relation thereto.

24. Defect liability period/ Guarantee/ Warrantee

The defect liability period for the work will be six (06) months from the actual date of completion of the work of above or after passage of one monsoon season, whichever is later; if any defect occur during this period then the contractor shall be liable to carry out required repair/replacement/rectification as per the direction of Engineer-in-charge at his own cost. The tenderer shall warrant that the item supplied under the contract/order is new, unused, of current design and shall be free from all defects and faults in material, workmanship and manufacture and shall be of the highest grade.

The equipment/ items will be in consistent with the established, recognized or stipulated standards for materials of the type ordered and in full conformity with the specifications, drawings or samples if any. This warranty shall survive inspection and acceptance of the goods.

The tenderer shall provide guarantee/warranty for the satisfactory performance of the items supplied/ installed for a period of six months from the date of final handing over/ date of work completion to RSMML

25. Risk & Cost

The Company shall have full right to forfeit the wholly security deposit and payment of other pending bills payable to contractor for non fulfillment of the contractual obligations within the scheduled/specified time period. 26. LEGAL & STATUTORY OBLIGATIONS:

- ii. The contractor shall have valid Labour License and deduct PF as per rules for all employees/workmen engaged for this work. The proof of deduction & deposition of PF shall be submitted to RSMM.
- iii. The contractor shall be liable for all persons employed and / or engaged by him whether directly or otherwise in all respects and also for all the equipment's deployed by them under their control, under various statutory provisions in force from time to time as amended upto date such as Workmen's compensation Act, 1923, Employees Provident Fund Act 1952, Payment of Gratuity Act, 1972, Contract Labour (Regulation and Abolition) Act 1970, Payment of Wages Act, 1936; Minimum Wages Act 1948, Payment of Bonus Act, 1965, Indian Railways Act 1890, Fatal Accident Act, 1855; Industrial Disputes Act, 1947, Mines Act, Factory Act and or any other allied Central or State enactment's, rules, regulations and bylaws made there under. The Contractor shall maintain and produce whenever called for, all records required under various Acts, Laws & By Laws.
- iv. The contractor shall maintain and provide records including attendance register in case of maintenance work of all his employees including supervisors, at the site.
- v. These registers are duly maintained and updated so that the same is available for inspection by any statutory authority & the company.
- vi. The contractor shall keep the company indemnified against all the claims and liabilities of his direct or indirect employees, contracted

employees engaged in respect of this contract, under the aforesaid acts, rules, regulations and bye laws as may be in force from time to time during the period of the contract or otherwise for or in respect of any claim, damage, compensation etc., whatsoever payable in consequence of any loss, damage, accident or injury etc. sustained by persons including the employees of the company, which shall be recoverable from the running bills and/or security deposit of the contractor.

- vii. The contractor shall have to make all payments to the staff etc. engaged by him every month latest by 7th day of following month.
- viii. - xiii. All the provisions of Rajasthan Transparency in Public Procurement Act and rules made there under and modification to be issued by the competent authority from time to time will automatically be ipso-facto applicable.

In case of any dispute, it shall be the endeavor of both the parties to resolve it through mutual discussions. No courts other than the courts located at Jaipur-Rajasthan shall have jurisdiction over any matter concerning any aspect of the work under this tender. The contractor shall not stop or abandon the work due to and during the pendency of such disputes or differences.

(1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued thereunder, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:
